Annual Parish Meeting Minutes February 27, 2022

9:15-9:45 am

The annual meeting of St. John's Episcopal Church of Sharon, PA was held at 9:15 am, Sunday, February 27, 2022. Fr Adam Trambley called the meeting to order immediately following the invocation and recitation of the Lord's Prayer. All meeting materials were available to everyone in the form of a brochure. It was determined that a quorum was present.

Victoria Barletta was appointed secretary. Robert Barletta was appointed parliamentarian.

The parish necrology was read. A moment of silence was observed followed by Prayers for the Departed.

Minutes of the 2021 Parish Annual Meeting were accepted as presented on the motion of Tracy Schliep, seconded by Robert Barletta

Ron Gracilla was appointed teller (if needed) for Vestry Elections.

Nominees to three-year vestry terms were announced: John Kachursky, Madge Tamber and Becky Yoho. Nominations were closed on the motion of Nick Baron, seconded by Barb Lipinski. Kachursky, Tamber and Yoho were elected to the vestry by a unanimous ballot. Victoria Barletta moved to accept the ballot, and Robert Barletta seconded it.

Outgoing Senior Warden Tracy Schliep talked about the parish's losses and gains that were experienced this past year as well as the cherished parts of our life together that have managed to stay constant. She thanked the vestry for all the hard work and cooperation, thanked Ron for his technical as well as spiritual creativity, and thanked Fr Adam for his effective leadership.

Father Adam thanked Tracy for the incredible help she has provided in her role as Senior Warden as well as her position in the Mercer Co. healthcare system. He also thanked outgoing Junior Warden Barb Lipinski for the many roles she has played in the St. John's family.

Father Adam also thanked outgoing Treasurer Donna Stamoolis and in her absence discussed the Treasurer's Report. Our revenue continues to be strong, and we are doing OK given the difficulties of the past two years. We have managed to do some cost-cutting in the 2022 budget and have reduced the deficit we ran in the 2021 budget. Our investments did very well in 2021, and that has helped to keep us in a very stable fiscal position.

Father Adam answered a question regarding the work on the sanctuary floor that still needs to be accomplished. He noted that there are 2 facets of that work: a structural problem where several of the supporting beams had been cut out and will need to be replaced and a practical problem of a bulge in the floor resulting from the placement of shims in an attempt to correct a sagging beam that runs from back to front of the sanctuary. This bulge makes the choice of new flooring a challenge. Jesse Fisk has given us bids for both of these projects, which we have accepted. We do not at this time have a date when work on these projects will begin.

Voting Rules

During the 2023 Annual Meeting, three people will be elected to the Vestry.

Diocesan Canons require that Vestry Members be Lay Persons in Good Standing. A Lay Person in Good Standing is a person whose Baptism has been recorded in this Church, who has received Holy Communion in this Church at least three times during the preceding year and who for the previous year has been faithful in corporate worship, unless for good cause prevented, and has been faithful in working, praying and giving for the spread of the Kingdom of God; and who is in union with the convention of this Diocese and who is not prevented from receiving Holy Communion under the Disciplinary Rubrics of the Book of Common Prayer.

Those eligible to vote at Annual Meetings, according to Diocesan Canons, are A Lay Persons in Good Standing of the Parish who are physically present, who are at least 18 years of age, who are regular attendants at the services of the local church, and who are regular contributors for the six months preceding the meeting to the support of the local church and to the work of the Diocese and National Church as shown on the books of the Treasurer.

Note that eligibility to serve on vestry and vote at the annual meeting is now defined in Diocesan Canon.

Vestry Candidates

The Nominating Committee of the Parish Vestry has reported the following slate of three candidates for election. They not only meet the minimum qualifications for Vestry candidates as stipulated, but also, in the opinion of the Nominating Committee, have other qualities which make them worthy candidates for election to the Vestry.
